Ours is one of the Cape's oldest working wine farms, founded almost 330 years ago. The complex of beautifully restored classic, Cape Dutch 18th-century buildings is a National Monument.

VALENTINA'S CHAPEL

Our dedicated ceremony space, bathed in natural light, with exquisitely hand-crafted finishes and timeless wooden pews.

Capacity: Maximum of 80 guests

VENUE FEATURES

- Intimate, tranquil space with vineyards in the background, hand-crafted finishes, fine wooden pews, internal sound system, microphone, stage, backroom
- No food or drink permitted; sound is limited to ambient or pre-approved setups





GEUWELS RESTAURANT

Clean-lined, modern interiors contrast with the classic Cape Dutch aesthetic

Accommodates a minimum of 30 guests

Available for pre-wedding dinner/s and/or welcome gatherings

VENUE FEATURES

PRE-WEDDING DINNER

- Capacity: maximum of 50 guests
- Use: 17h00-21h30 the evening before the wedding
- Venue fee: included in Estate Affair
- Catering: 2/3-course menu, harvest table, or braai
- Ambient music only; estate beverages only; décor restrictions apply.





THE WERF

Our classic Cape courtyard between Clara's Barn and the Homestead can accommodate an outdoor wedding ceremony or provide a cocktail reception area for a maximum of 80 guests.

VENUE FEATURES

- Venue fee: included in Estate Affair / R7 500 for Intimate Gathering
- Outdoor courtyard with ambient lighting and vineyard backdrop
- No marquees allowed, wedding party to bring in all furniture; fully weather-dependent



AMY'S ISLAND

The idyllic alternative

Our glorious island on the *vlei* can accommodate up to 80 guests for an outdoor ceremony or pre-reception drinks and canapés.

VENUE FEATURES

- Venue fee: included in Estate Affair
- Island ceremony space with no permanent structures or direct bathroom access
- Fully weather-dependent; foot access only





CLARA'S BARN

Exquisite heritage building and one of the Cape's oldest barn structures with reimagined modern finishes. See how the original feeding troughs are integrated into the design, and also, the reproductions of the 18th century Jan Brandes paintings.

Accommodates between 40 and 80 guests.

VENUE FEATURES

- Venue fee: included in the wedding package
- Mandatory 5-course set menu catering
- Optional add-ons: canapés, oyster bar, harvest table, dessert bar, late-night snacks, wine pairings
- Pre-Wedding Setup: 08h00-16h00
- Post-Wedding Breakdown: By 09h00
- Venue closes at 00h00 sharp; overtime charged at R5 000/hr



THE HEARTH ROOM

VENUE FEATURES FOR CANAPÉS OR BREAKFAST

- Standing capacity: 80 / seated: 50

- Catering: canapés, brunch, harvest table, cocktails
- Exclusive to Estate Affair package
- Soft music only; no external catering allowed

VENUE FEATURES VIP DINING

- Use: private wine pairing, welcome dinner, or family brunch
- Venue fee: included in both wedding packages
- Catering: canapés, pastries, private chef option
- Indoor lounge, veranda, pool deck, and jacuzzi available
- No DJs or amplified music; outdoor use permitted with discretion



GENERAL INFORMATION

BOOKING PROCESS

1. Initial enquiry (email, phone, or website)
2. Info pack shared (brochure and T&Cs)
3. Venue selection based on availability
4. Menu selection: 5-course menu and add-ons
5. Quotation issued (based on guest count and menu)
6. Quotation accepted and signed
7. Contract finalised
8. 50% deposit due within 14 days of quotation acceptance
9. Final payment due 30 days before the wedding

BOOKINGS AND PAYMENT

- Provisional bookings are held for 14 days
- Booking is confirmed once a 50% non-refundable deposit is received
- Final balance is due 30 days before check-in unless otherwise arranged
- Damages or breakages will incur additional charges

CANCELLATION POLICY

- Deposits are non-refundable.
 - Date changes must be requested in writing 6+ months in advance.
 - Changes subject to availability and handled case-by-case.

TIMES: ACCOMMODATION / SETUP / CATERING

- Check-in: 14h00
- Check-out: 10h00
- Full property buy-outs may qualify for earlier access on request
- Breakdown from Clara's Barn must be completed by 09h00 the next morning

STAFFING

- Dedicated venue manager included on event day
- Waiters, bar staff and housekeeping staff included
- Décor setup/breakdown staff to be booked via planner from approved suppliers
- Vergenoegd Löw staff may not assist with décor setup and breakdown

COORDINATION

- A professional wedding coordinator is required for all weddings
- A list of recommended planners is available upon request



GENERAL INFORMATION

TRANSPORT

- No guest transport provided
- Golf carts are reserved for on-property hotel guest use
- We recommend shuttle services for off-site events and can identify suitable suppliers

PRE + POST EVENTS

- Getting-ready catering platters
- Group wine tastings

ENTERTAINMENT & NOISE RESTRICTIONS

Vergenoegd Löw is a working wine estate and abides by strict noise regulations:

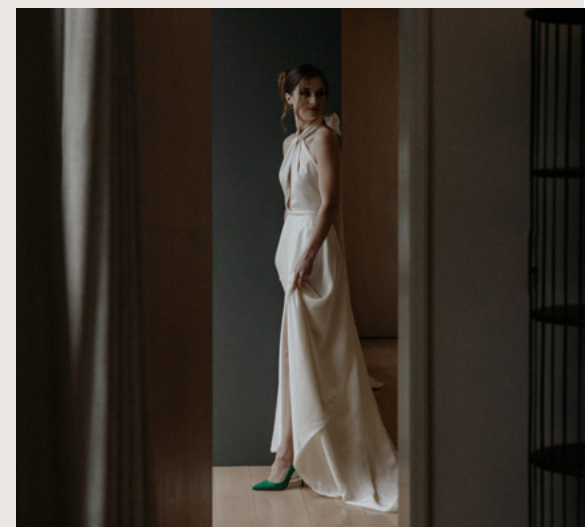
- All amplified music must stop by 00h00
- Bass levels must be reduced from 23h30
- No amplified sound in the Manor House courtyard, spa gardens, or conservation zones
- Management reserves the right to end events if sound limits are exceeded

BAR & BEVERAGES

- We are a fully licenced estate; all beverage service is managed in-house
- Outside alcohol will only be permitted with prior written approval
- Curated wine list available; wine selections due 30 days before wedding
- Sourced alcoholic beverages are invoiced and procured directly by our team; no consignment stock will allowed
- Vergenoegd Löw wines are available at cellar door prices

ACCOMMODATION

- Accommodation payments due within 14 days of finalising the contract
- Guests not included in the couple's package may book at a discounted rate, depending on room availability
- Included accommodation is secured by the couple and will not be billed to guests but to the persons responsible for the wedding event
- A value breakdown per person is available to assist in planning individually paid contributions
- Once guest payments are received, the initially quoted fee is amended: deducted or refunded accordingly
- Full balance due 30 days prior to arrival
- Late or missing proof of payment may result in cancellation and forfeiture of 50% deposit



SECURE YOUR DATE



All rates are quoted in South African Rand (ZAR) and include 15% VAT. To ensure your special day is reserved exclusively for you, a 50% deposit of the total wedding package fee is required.

Payment can conveniently be made via EFT, direct bank deposit, or credit card.

By securing your booking with a deposit, you confirm your acceptance of Vergenoegd Löw Boutique Hotel and Spa's payment, cancellation, and postponement policies. A provisional reservation will only be confirmed once we have received proof of payment.

Please note that rates may be subject to change without prior notice. The remaining balance is to be settled on or before checkout. A late payment fee will apply for payments made after this date.
